Recommendation:

3. Public Facilities and Serviced Goals, Policies, and Implementation Measures

Subject:

The *Public Facilities and Services Element* is a permissive element of the General Plan providing guidance regarding the development of public facilities and provision of services supporting community residents and businesses. It is a permissive element and focuses on facilities and programming for police and fire/safety, education, and arts and culture and their quality, operation and maintenance, and financing.

Recommendation:

It is recommended that the General Plan Advisory Committee review the draft preliminary goals, policies, and implementation measures, confirm their appropriateness for the City, and identify any missing goals and policies.
